WAIVER AND RELEASE FROM LIABILITY

As a participant in the ENGADINWIND in Silvaplana/Switzerland from **19.-23.08.2020**:

1. I am obligated to observe the organizer's rules in accordance with the invitation, as well as the official notice of race and the regulations announced at the obligatory competition meeting.
2. I hereby release the organizer, the coordinators and helpers at the ENGADINWIND in Silvaplana/Switzerland from **19.-23.08.2020** and the related activities from all claims of liability, to the extent that these are not covered by the legal liability requirements. This includes all direct and indirect damages and all claims that I, my heirs or authorized third parties could assert as a result of injuries suffered or death. This does not apply if the damages are the result of gross negligence or intentional actions by the organizer, the coordinators or the helpers.
3. I release the above-mentioned persons from any liability towards third parties to the extent that they suffer damages during the event as a result of my participation at the ENGADINWIND in Silvaplana/Switzerland from **19.-23.08.2020**.
4. I know and am in agreement with the fact that I bear the sole responsibility for my property and sports equipment during the ENGADINWIND in Silvaplana/Switzerland from **19.-23.08.2020** and the related activities.
5. I know and am in agreement with the fact that the ENGADINWIND in Silvaplana/Switzerland from **19.-23.08.2020**, contains a random component. I am therefore aware that participating at the event involves uncalculated and unavoidable risks.
6. I hereby ensure that I know the competition grounds and possess all necessary technical, conditional, and physical skills to participate in the training and the competition. I am obligated to report concerns and suggestions for improvements before the start personally to the jury or the persons responsible for safety. Regardless of the seriousness of my concerns, by starting, I recognize that I consider the given state of the competition area and the existing safety measures to be appropriate and satisfactory and that I have the obligation to report all concerns about the safety of the competition area and that my failure to report this is to be considered a waiver of any claim resulting from this.
7. I expressly declare my agreement that I be medically treated during the ENGADINWIND in Silvaplana/Switzerland **19.-23.08.2020** if this should be necessary when injuries occur in the event of accidents and/or illness during the competition.
8. The athlete permits the organizer to use his name, his initials, his voice, his signature, his likeness and visual and audiovisual images of him worldwide and with no restrictions concerning the time in connection with the exploitation of the event, either complete or in parts, in television, in the Internet, and in mobile equipment. This permission also includes the use for advertising purposes for comparable events of the Organizer and their exploitation in television, Internet and in mobile equipment, as well as the exploitation of the Event in video and multimedia productions and in connection with merchandising. The permission further includes the use by media representatives permitted by the Organizer in the context of reporting on the Event.
9. The organizer reserves the right to cancel the event due to bad weather or as a result of obligations imposed by the authorities or force majeure. Registration fees already paid will not be returned. I am obligated not to assert additional claims.

In signing this form I confirm that I am over 18 years of age and have current medical insurance. I understand that the nature of this contest holds an element of danger and risk and I accept responsibility for my conduct and any resulting injury to myself or a third party. I agree not to bring any action or claim for injury, loss or material damage as a result of participating in this event against the organizing committee, the sponsors, PL Sports Consulting GmbH and all others involved in the event.
